## **General Description:**

We are seeking to hire a Warehouse Technician to work at the Eagle Mine. Eagle Mine is located in the Upper Peninsula of Michigan, USA. Reporting to the Warehouse Supervisor, this individual will be responsible for maintaining warehouse inventories at the mine or mill location.

## **Key Responsibilities:**

- Identify and inspect all incoming materials against manifest, invoice, packing slip and purchase order to ensure accuracy.
- Document issues, receipts and return of materials in applicable ERP in a timely manner.
- Conduct the receipt, stocking and inventory maintenance process of incoming materials.
- Load and unload trucks, trailers, railcars, vans and storage racks.
- Perform general housekeeping tasks such as sweeping, cleaning, etc.
- Fulfil orders for outbound materials, and package or kit for delivery or pickup.
- Sort and palletize materials.
- Operate material handling equipment and other vehicles.
- Record necessary documentation to support all warehouse transactions.
- Perform inventory control functions including stock order placements and min/max system settings.
- Perform routine physical counts of inventory on hand.
- Accomplish additional duties as required.
