MAIN RESPONSIBILITIES/ACTIVITIES:

- Ensure Eagle Mine Heath, Safety, and Environmental (HSE) Standards are followed, and to continuously promote awareness among employees.
- · Perform major and minor mobile equipment repairs, and complete preventative maintenance activities.
- Perform and manage mobile maintenance lubrication routes.
- Provide assistance to mechanical maintenance department.
- Rebuild pumps, cylinders, and hydraulic systems as needed.
- Inspection of all critical mobile lifting equipment for defects.
- Perform all annual inspections per MSHA requirements.
- Operate various light and heavy equipment as needed.
- Ability to respond to emergency afterhours Mobile equipment failures.
- Assist and train others as needed to improve efficiency and quality.

- Minimum of 8 years working as a Heavy Mobile Maintenance Mechanic required.
- Mobile Maintenance Mechanic Certifications preferred.
